Remedial Summer School Information:

- Offered to students who did not successfully complete courses previously taken during the 2024-2025 school year. Summer School will be offered in-person.
- Registration form created by the counselor.
- Class Assignments - Classes are assigned by the summer school administrative team based on enrollment, need, and the availability of certified teachers. Courses that are cancelled due to insufficient enrollment or lack of certified teachers will result in a full refund or the opportunity for the student to select another available course.
- Students can recover credits for a maximum of two courses.
- Attendance Procedures--Efficient use of class time is essential to the student's success. Refunds will be not given to students who are withdrawn for lack of engagement or progress in coursework.
- Discipline Guidelines - All students will follow the FBISD Student Code of Conduct. Students refusing to adhere to the code of conduct who receive a second (2nd) discipline referral will be withdrawn from summer school without receiving a grade for the session regardless of the date within the session will result in the student being immediately withdrawn from summer school and no refund issued. This action will be taken without receipt of a grade/credit for the session regardless of the date within the session on which the incident occurs. Refunds will not be given to students who are withdrawn for discipline reasons.
- Payment must be made in SKYWARD/RevTrak by credit/debit card. Checks will not be accepted. Full payment is required at the time of registration. Refund requests will not be accepted or approved once classes begin on the first day of each session.

Refund Procedures

- All allowable requests for refunds must be made in writing to the summer school principal and approved by the principal.
- A \$25 processing fee will be deducted from each approved refund. Refunds will be given due to the cancellation of classes and will not be subject to a processing fee. Allow up to 4 weeks processing time.

Original Credit - Course Offerings

Students taking summer school in the face to face format for original credit have the opportunity to engage in learning during the summer. Doing so may provide space in the student's schedule to take other courses during the school year. Three classes will be offered for original credit via the face-to-face (in person) format: Professional Communications, Health, and Physical Education. Students interested in enrolling in other courses for original credit may explore the Summer O-Lab offerings.

Original Credit Information:

- **Students who failed during the regular term due to lack of attendance must repeat the course as an original credit course if offered.**
- Original Credit Courses (counselor's permission required) are for students who are taking a course for the first time or students who are repeating a course due to excessive absences or denied credit.
- Class Assignments - Classes are assigned by the summer school administrative team based on enrollment, need, and the availability of certified teachers. Courses that are canceled due to insufficient enrollment or lack of certified teachers will result in a full refund or the opportunity for the student to select another available course.
- Attendance Procedures--Efficient use of class time is essential to the student's success. Refunds will be not given to students who are withdrawn for lack of engagement or progress in coursework.
- Discipline Guidelines - All students will follow the FBISD Student Code of Conduct. Summer O-LAB Course Offerings

Summer O-LAB is offering original credit courses to be taken via Edgenuity, a purchased curriculum. Because all assessments must be proctored, students must take their quizzes, tests, and exams on campus. Students report to the Summer O-LAB classroom at the campus they will attend the following school year. Due to constructions several campuses will be moved to alternate locations.. Summer O-LAB information:

- Summer O-LAB will also offer Summer Senior Rescue for students planning to graduate in August.
- Student-athletes who may be pursuing NCAA, NAIA, or NJCAA eligibility should be aware that coursework completed via Edgenuity may not meet program requirements. UIL eligibility may also be impacted.
- Incoming 9th-grade students may only take Art IA or Art IB. See the Summer O-LAB website for more information.
- Information including registration and payment instructions for Summer O-LAB courses will be published separately. The curriculum will include the use of online courses from Edgenuity with proctored, in-person assessments and exams.
- Original Credit Courses (counselor's permission required) are for students who are taking a course for the first time or students who are repeating a course due to excessive absences or denied credit.
- Payment must be made in SKYWARD/RevTrak by credit/debit card. Checks will not be accepted. Payment is due after the counselor has approved the application. Refund requests will not be accepted or approved once classes begin on the first day of each session.

Refund Procedures

- All allowable requests for refunds must be made in writing to the O-LAB teacher.
- A \$25 processing fee will be deducted from each approved refund. Refunds will be processed from May 8th through June 11th. Allow up to four weeks processing time. Refund requests will not be accepted or approved once classes begin on the first day of each session.

Special Note:

- Full payment is required at the time of payment. Once you submit your registration allow two business days and then check Family Access to see if the fee has been generated.
- Students will need to register online by selecting courses and paying online with a credit/debit card through Fort Bend ISD's Family Access - go to www.fortbendisd.com (Family Access is an icon at the top right side of the home page).
- Parents/students needing assistance with registration should visit their campus counselor.
Out of district students are able to attend FBISD Remedial Summer School if their home district is not offering a summer school. An additional \$100 administrative fee will apply unless parent/guardian is able to verify residence (a utility bill may be used for verification). The out of district registration date is June 3 from 9-11 a.m. at Austin H.S.
- Parents may contact the FBISD Customer Support Center at 281-634-1300 for Family Access assistance.
- REGISTRATION FOR ALL COURSES IS ON A FIRST COME FIRST SERVED BASIS AND WILL DEPEND ON THE AVAILABILITY OF QUALIFIED TEACHERS.
- Space is limited, and some courses will close before the registration end date (March 28 for Original Credit, Remedial May 30, 2025)
- Transportation will be provided for FBISD summer school students. Pickup and drop-off locations will be provided during registration.
