


STAAR Approaches Grade Level or Above, 2024 Grades 3-8 and EOC


STAAR Approaches Grade Level or Above by Student Group, 2024 Grades 3-8 and EOC All Subjects


STAAR Meets Grade Level or Above, 2024 Grades 3-8 and EOC


STAAR Meets Grade Level or Above by Student Group, 2024 Grades 3-8 and EOC All Subjects


2023-2024 STAAR Masters Grade Level Grades 3-8 and EOC

STAAR Masters Grade Level by Student Group, 2024 Grades 3-8 and EOC All Subjects





Annual Growth, 2023 and 2024







4-Year Longitudinal Graduation Rate Classes of 2022 and 2023




College Career and Military Readiness 2021-2022 and 2022-2023 Annual Graduates



Ethnic Distribution


