### MCJROTC CONTRACT (2023-2024)

I, Cadet \_\_\_\_\_\_, agree and promise to comply with the following rules and regulations. If I do not, I understand that I may be dis-enrolled from the JROTC.

- I will obey the rules for Travis High School students as explained in the Student Handbook and the Cadet Handbook, which I have read and understand.
- I will treat others and others' property with respect.
- I understand that others will judge me by my conduct not just in JROTC but in all my classes. I will conduct myself as a gentleman/lady in all my classes. I understand that being bad behavior is a poor reflection on me, my school, and my unit and I will accept the consequences of my actions.
- I will wear my uniform properly on all prescribed occasions. I understand that, if I fail to wear the uniform on the prescribed occasions, I will receive a grade of "0" for that day and that frequent failure to wear my uniform may result in being dropped from the JROTC. I understand that I may change out of uniform for classes that require it (for example, PE), but will put the uniform back on before the end of that class.
- I will address the instructors by "Sir" or their rank and last name.
- I understand physical training (PT) is an important part of the JROTC program and will bring my PT gear on the prescribed occasions. If I fail to do so, I will be given a grade of "0" for that day. I understand that frequent failure to bring my PT gear will result in being dropped from the JROTC program.
- I understand that my attendance in school is important to my learning experience and success. I agree to come to school regularly. Frequent absences will lead to losing credit for class and/or being dismissed from the JROTC program.
- I understand that as a cadet I will be required to do physical fitness training. This physical training will consist of individual and group effort. I will give a 100% effort when participating in physical training.
- I understand that academic success is a primary goal of JROTC and agree to do my very best to be successful in all my courses, not just JROTC. If I am having problems in a class or classes, I will go to tutorials for help. I also understand that promotions are based on academic success. If I fail courses, it may affect my eligibility for promotion.
- I understand that giving back to the community is an important part of leadership. I understand that I will be encouraged to do a minimum of twenty (20) hours of community service per year. This service can be with the JROTC sponsored functions or may be with other organizations (church, civic organizations, etc.) or projects I find on my own. For credit for my hours done with other organizations, I must bring proof of service from the organization(s).
- I understand that communicating with my parents/guardians is a very important aspect of leadership. I understand that I will be given documents to give to my parents for information and/or signature. I agree to have them signed and returned in a timely manner.

I have read the above contract. By my signature below, I agree to follow the rules of the school and JROTC. My parents have signed to indicate that they have also read this and agree to help me reach my goals.

# PARENT/GUARDIAN PERMISSION FORM (2023-2024)

## RELEASE AND HOLD HARMLESS AGREEMENT

This Release and Hold Harmless Agreement ("<u>Released</u>") is made and entered into as of the date signed below, between the Marine Corps JROTC Instructors and the undersigned student and parent/guardian.

Marine Corps JROTC programs provide an opportunity for cadets to experience leadership training, confidence building, team building, strength and conditioning, and other developmental opportunities throughout the year including periods when school is not in session. The intent of the training is to develop young men and women to be physically fit, good citizens, who have confidence in themselves. This training comes in various forms, including standard physical fitness training, adventure training, practical application, and classroom instruction. Marine Corps JROTC instructors will never intentionally put your cadet in danger or in a situation where injury could occur; however, "high risk" training, such as rappelling, high rope courses, zip lines, obstacle and confidence courses, swimming and rafting do come with some inherent risk. Ultimately, it is the parents (guardians) decision to allow a cadet to participate and by doing so, you will not hold the instructors liable should injury or death occur.

I AGREE TO ASSUME AND DO ASSUME FOR ALL PURPOSES ANY AND ALL RISKS OF INJURY WITHOUT RESERVATIONS, THEREBY RELEASING AND FOREVER DISCHARGING THE INSTRUCTORS, THEIR TRUSTEES, DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS, AND I AGREE TO INDEMNIFY AND HOLD HARMLESS EACH AND ALL OF THE INSTRUCTORS PARTIES FROM AND AGAINST ANY AND ALL CLAIMS, ACTIONS, SUITS, PROCEDURES, COSTS, EXPENSES, DAMAGES AND LIABILITIES INCLUDING, BUT NOT LIMITED TO, ATTORNEYS' FEES ARISING OUT OF, CONNECTED WITH, OR OTHERWISE RESULTING FROM ANY INJURY, DEATH, HARM OR LOSS I, MY CADET OR ANY MINOR PERSON WITH ME, OR WHOM I HAVE PROVIDED PERMISSION MAY SUFFER WHILE PARTICIATING IN LEADERSHIP TRAINNING ACTIVITIES IN CONJUNCTION WITH THE MARINE CORPS JROTC PROGRAM. I UNDERSTAND AND AGREE THAT THE RELEASE, INDEMNITY AND HOLD HARMLESS CONTAINED HEREIN SHALL APPLY AND BE ENFORCEABLE REGARDLESS OF ANY CONCURRENT NEGLIGENCE, OR THE SOLE NEGLIGENCE OR OTHER FAULT OF ANY ONE OR MORE OF THE INSTURCTORS PARTIES. I specifically agree that this Release is reasonable, the preceding provisions of this paragraph are conspicuous, this Release is fully enforceable, and that my execution hereof is completely voluntary. I furthermore understand that I, or my minor cadet, must behave in a responsible manner, that I am responsible for any minor with me, or whom I have released while participating in Marine Corps JROTC leadership training. I agree that I, and my cadet, will obey and follow any rules implemented by the Instructors and made available to us. Should I fail to understand any of such rules, I will ask an Instructor for an explanation.

#### I CERTIFY THAT I HAVE READ THIS RELEASE AND FULLY UNDERSTAND AND AGREE TO ITS CONTENTS. AS USED HEREIN, I UNDERSTAND THAT THE TERM "I" INCULDES ANY MINOR PERSON WITH ME OR WHOM I HAVE GIVEN PERMISSION TO PARTCIPATE.

#### **INDOOR RANGE REGULATIONS**

The following general range regulations apply to all shooters who utilize the Travis High School, Marine Corps JROTC indoor range.

- 1. ALL CADETS MUST ATTEND A RANGE SAFETY CLASS AND SUCCESSFULLY COMPLETE A RANGE SAFETY EXAM PRIOR TO PARTICIPATING IN MCJROTC MARKSMANSHIP TRAINING.
- 2. CADETS WILL NOT USE THE RANGE UNLESS A PROPERLY QUALIFIED MCJROTC, MARKSMANSHIP INSTRUCTOR (RANGE OFFICER) IS PRESENT IN THE RANGE.
- 3. CADETS WILL NOT HANDLE AIR RIFLES WITHOUT A PROPERLY QUALIFIED MCJROTC MARKSMANSHIP INSTRUCTOR PRESENT.
- 4. ALL RANGE COMMANDS AND INSTRUCTIONS WILL BE GIVEN BY THE RANGE OFFICER ONLY. THE ONLY EXCEPTION IS THAT OF AN UNSAFE SITUATION WHEN ANY PERSON PRESENT MAY COMMAND "STOP".
- 5. ONLY AIR RIFLES AUTHORIZED BY THE MCJROTC PROGRAM WILL BE USED ON THE RANGE.
- 6. ALL AIR RIFLES WILL BE TREATED AS IF THEY ARE LOADED AT ALL TIMES.
- 7. CADETS WHO VIOLATE RANGE SAFETY REGULATIONS WILL BE BARRED FROM THE RANGE AREA.
- 8. ANY CADET WHO VIOLATES RANGE SAFETY REGULATIONS WILL HAVE TO RE-TAKE AND PASS THE RANGE SAFETY EXAM BEFORE BEING ALLOWED BACK INTO THE RANGE.
- 9. RANGE OPERATIONS WILL BE CONDUCTED IN ACCORDANCE WITH THE RANGE STANDARD OPERATING PROCEDURES (SOP) MANUAL.

These regulations are published to ensure the safety of the shooters and apply to all persons using the facilities of this range.
